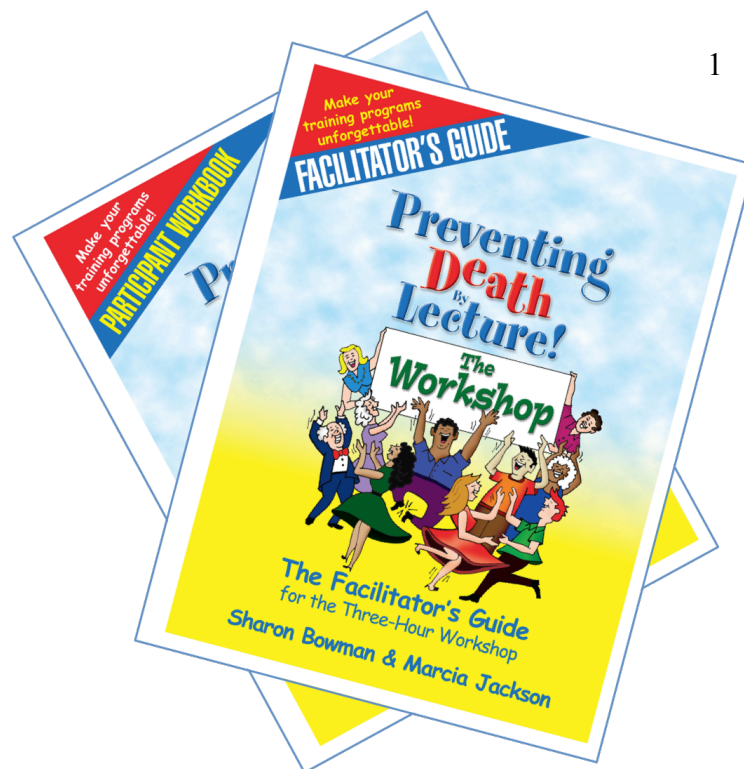


**Individual License
